1. CALL TO ORDER: The meeting was called to order by Chair Overholt at 6:30 p.m.

- 4. <u>APPROVAL OF MINUTES AS MAILED FOR MEETING OF March 21, 2017:</u> Mr. Heinrich moved to approve the minutes of the March 21, 2017 meeting; seconded by Mr. Du Clair. Motion carried. So ordered by 7-0.

- 8. <u>DIRECTOR'S REPORT:</u> In addition to Ms. Katz' report and in response to Mr. Overholt's inquiry on the *NASA@My Library* initiative, Ms. Katz explained that the grant will start in the Vacaville and Suisun libraries and the STEM (Science, Technology, Engineering and Math) kits and programs will be offered at the RIO, SUI, Vacaville and Vallejo branches. Ms. Katz informed the Council that during the month of May, with the Board of Supervisors' approval, veterans' fines and fees will be waived. This also gives the Library an opportunity to advertise the Veterans Connect @ the Library program. Ms. Katz explained that the Automated Materials Handling (AMH) proposal is available and there were five vendors that participated in the touring of the six libraries that the Library plans to install the equipment in. The budget is being finalized and will go to the Board of Supervisors at the end of June. The Library received a virtual reality grant and the FCC Library will have one virtual reality station set up. All of the grants, innovations, STEM, NASA, etc. are part of the Library's new strategic plan.

9. OLD BUSINESS:

a. Strategic Plan Presentation – the Council will receive a presentation by Deputy Director, Mark Fink, on the Solano County Library Strategic Plan 2017-2022

Mr. Fink presented the Solano County Library Strategic Plan and highlighted some of the areas of the plan: mission, vision and values, market strategies and next steps. The Board of Supervisors accepted the Strategic Plan at their April 25 meeting.

b. Appoint members to serve on the Measure L Oversight Committee – the Council will appoint members to serve a four-year term ending December 2021 on the Measure L Oversight Committee

Ms. Katz explained that the SCLAC needed to appoint members to represent the five cities of Fairfield, Rio Vista, Suisun, Vacaville and Vallejo on the Measure L Oversight Committee to serve a four-year term ending December 2021. Ms. Katz would contact the cities of Benicia and Dixon to appoint a representative from those cities. These appointments need to be agendized at a Board of Supervisors meeting.

Personnel

Recruitments

We are still in recruitment mode. We will be opening a recruitment for Librarian for three vacant full time positions, two at the Fairfield Library, an adult services and a children's position and one at Vacaville Town Square. We are also recruiting for an Information Technology Specialist II position due to an upcoming retirement.

Staff changes/promotions

We have been able to fill numerous positions since my last report. Two of the librarian vacancies occurred because of promotions. Elizabeth Molyneux has been promoted to the Supervising Librarian position at Technical Services. Beth began her career with the Library in 2007. She has been a Library Associate and most recently an adult services Librarian at the Fairfield Civic Center Library. Kevin Tolley has been promoted to Supervising Librarian at the Rio Vista Library. Kevin began his career in 2002 as an extra help librarian and most recently was the youth services Librarian at the Town Square Library.

Laurence Bacud is the new half time Library Associate at Cordelia. Laurence was a departmental aide at the Rio Vista Library. He holds a Bachelor's degree in Communications and Japanese from UC Davis. David Marsh has been hired as a half time Library Associate at the Suisun Library. David has worked for the East Bay Regional Parks District and has spent time as a Van Naturalist traveling to Bay Area schools presenting nature programs.

Miguel Loeza is the new half time Library Associate at the Fairfield Civic Center Library. Miguel's previous employment included working on a bookmobile in Illinois and as a Law Clerk for Allstate Insurance.

Summer Reading Program

Summer Reading Program is in full swing with programs for all ages. As you recall we have changed the format of the Summer Reading Program to a "challenge". Everyone from children to adults can read and win prizes. We began the program June 1 and it ends on August 31. To date we have over 5,600 folks signed up for the Summer Reading Program. The registrations for the different age groups are as follows: Pre –Reader - 983, Children – 2880, Teens – 940 and Adults – 1065.
